ARTICLES OF INCORPORATION

OF

ARTICLE I Name

The name of this corporation is

MONTEVALLE OF SANTA CRUZ, INC.

ARTICLE II

The purposes for which this corporation is formed are:

(a) The specific and primary purpose for which this corporation is formed is to own, provide management services, aintenance, preservation and control of that real property and improvements thereto in the County of Santa Cruz, State of California, described as follows: All of that real property described as

All of that real property described as the common area and existing for the use and benefit of lot owners and holders of membership certificates in this corporation within a subdivision or subdivisions to be formed pursuant to the laws of the State of California.

And, as a specific and primary purpose of the corporation, to improve, maintain and operate the said real property and improvements thereon as a mutually owned common area for holders of membership certificates in this corporation, including the builds and other improvements and facilities thereto, and to provide and furnish incidental and related social and recreational facilities as well as maintenance for its members of said common area, and likewise to exercise such jurisdiction of the parcels of real property owned by the owners holding membership in the corporation pursuent to the provisions of the Ey-Laws of the corporation and the recorded Declaration of Covenants, Conditions and Restrictions. As and for this purpose, it is specifically acknowledged that it is the intention to develop the subject real property into separate units, referred to as Unit #: and Unit #2, and that each of said Units shall have Declaration of Covenants, Conditions and Restrictions, and further and likewise that concurrent with the recording thereof for Unit #1 linere shall be recorded by express written intent a Deckration of Reciprocal Covenants and Easements which shall express the intent and obligation that there shall thereby be a common control and administration of the whole of the real property.

- (b) To regulate the times, the nature, and other matters related to the use of the facilities owned by and operated by the corporation.
- (c) To provide safe and convenient use of the subject holdings of the corporation and for the maintenance Wiersot.
- (d) The corporation shall not earn profits for distribution to its members, except upon dissolution or except in order to carry out its other purposes.
- (c) To engage in any lawful activity normally incidental to its purposes, or such other activities beneficial and agreeable to its membership. and to possess and exercise all the powers conferred by law upon non-profit corporations, and to have all other powers and do all other acts necessary or incidental to the administration of the affairs and the carrying out of the purposes of this corporation.

ARTICLE III Membership Rights

The sufficiend number and qualification of the members of the currocation, the different classes of membership, if any, the voting rights, and other rights and privileges of members, and the obligation of members, shall be as set forth in the By-Laws of this corporation.
